<b>3. REGISTRATION OF HORSES ALREADY REGISTERED with another purebred TWH Registry:</b> Applications must be accompanied by a photocopy of both sides of the certificate.

<b>4. TRANSFER OF OWNERSHIP</b> If horse has been gelded or spayed, notify CLRC when transferring & no charge will be added to the transfer fee.
